Subject: The appointment of auditors

The Board of Directors of Ham Engineering Solutions Public Company Limited ("the company") at the meeting No. 3/2020 held on Thursday, April 16, 2020 passes a resolution to indefinite postpone the 2020 Annual General Meeting of Shareholders ("AGM) due to the outbreak of the corona virus Disease 2019 (COVID-19). Ltd., whereby one of the following auditors as the auditor and signing the Company's 2020 financial statements and also fix the remuneration the annual audit fee and quarterly review fee totaling Baht 1,406,000 (not including VAT and other expense). Which the Company will propose for approval by the AGM for the appointment consider approve the 2020 Annual Appointment of Auditors and Determination of their Remuneration in the upcoming AGM.
